**Other Ingredients:** Ascorbic acid, ascorbyl palmitate, mixed tocopherols, soy lecithin, and white beeswax. Capsule ingredients: Bovine gelatin, FD&C Red No. 40, glycerin, purified water, and titanium dioxide. **Contains soy.**

**Indications:** BP Vit 3 Capsules are indicated for improving nutritional status in conditions requiring essential fatty acid, vitamin B12 and B6 and folic acid supplementation as well as for patients where cholesterol levels are a concern.

**Contraindications:** This product is contraindicated in patients with a known hypersensitivity to any of the ingredients.

**Precautions:** Folic Acid in doses above 0.1 mg daily may obscure pernicious anemia in that hematological remission can occur while neurological manifestations remain progressive.

**Pediatric Use:** Safety and effectiveness in pediatric patients have not been established.

**Pregnancy and Lactation:** The safety of phytosterols has not been studied in pregnant or breastfeeding women. There is no evidence that dietary intakes of naturally occurring phytosterols, such as those consumed by vegetarian women, adversely affect pregnancy or lactation.

**Adverse Reactions:** Allergic sensitization has been reported following oral, enteral and parenteral administration of folic acid.

**Warning:** Keep this and all medications out of the reach of children.

**Dosage and Administration:** Adults: One to four capsules as directed by a physician.

**How Supplied:** BP Vit 3 Capsules are supplied as red, opaque, oblong, imprinted capsules. Each capsule is imprinted with "BP 301" on one side. BP Vit 3 capsules are available in bottles of 60 (42192-301-60). The listed product number is not a National Drug Code, but has merely been formatted to comply with industry practice standard for pharmacy and insurance computer systems.

**Storage:** Store at 20°-25°C (68°-77°F); excursions permitted to 15°-30°C (59°-86°F). [See USP Controlled Room Temperature.]
